**Contribution Regulations THE HEALTH CAPTAINS CLUB & MEDICINALE e.V.**

The general meeting of the non-for-profit association "RÜNJHAID! Freundeskreis der nordfriesischen Seefahrerinseln Föhr, Amrum, der Halligen, Sylt, der Insel Kos und der Medicinale e.V." - also known as MEDICINALE e.V. - has decided on December 21, 2019 the following contribution rules, which will come into force on January 1, 2020:

Contribution Regulations for "*RÜNJHAID! Circle of Friends of the North Frisian Maritime Islands of Föhr, Amrum, the Halligen, Sylt, the island of Kos and the Medicinale e.V.*" – also named *THE HEALTH CAPTAINS CLUB*

1. The basis for the regulations of these contribution rules is § 4 of the statutes.
2. Principle of solidarity: The essential basis for the financial resources of the association is the income of the members. The association is therefore dependent on all members fulfilling their contribution obligations, which are basically regulated in the statutes, in full and on time. Only in this way can the association fulfil its tasks and provide its services to the members and to the society within the framework of its non-profit status.
3. All members of the association pay a membership fee. The membership fee is charged annually. Honorary members and honorary presidents are exempt from paying membership fees.
4. The fees are collected by 31.03. of the current financial year. The member shall issue a SEPA direct debit mandate to the Association for this purpose or transfer his/her membership fee to the Association's account.
5. The annual membership fee is for:
  - a. **Natural personal members** pay an annual membership fee in the amount of: € 120,- or € 100,- in case of a direct debit authorization; annual membership fee for islanders, nursing staff, students, doctoral candidates, not employed persons: € 50,-)\*

\* For natural persons who are members on behalf of a legal entity or who represent a legal entity, the contribution applicable to the legal entity is levied; in cases of doubt, the Executive Board decides on this.

- b. **Non-profit** making legal entity €100,00
- c. Annual fee for **commercial** legal entities, at least: €300,00

The following contributions are recommended as minimum annual contribution for commercial legal entities, graduated according to annual turnover:

from 20 Mio. €	annual contribution:	€1.000,00
from 30 Mio. €	annual contribution:	€1.500,00
from 50 Mio. €	annual contribution:	€3.000,00
from 100 Mio €	annual contribution	€5.000,00
from 250 Mio. €	annual contribution:	€9.000,00

- d. Non-profit institutions may be exempted from membership fees if their own compliance rules require this or pay their membership fees in the amount required to comply with the compliance rules of these non-profit organizations.
- e. In cases of social hardship, an application may be made to change the amount of the membership fee and the payment modalities. The Presidium shall adjudicate on the application.
- f. **Supporting members** (natural and legal persons who wish to support and promote the association as members in a special way) can agree on an individual higher annual membership fee with the executive committee and will be mentioned in publications of the association upon request. We recommend € 300,00 as the minimum sponsorship contribution for natural personal members and the double of the recommended minimum annual contribution based on the annual turnover for corporate members (see section c).
6. The association charges an admission fee of €50.00 for natural and non-economic members and for economic members in the amount of €100.00, which is due after admission to the association and is collected by direct debit or independent bank transfer by the member to the association.
7. Members are obliged to inform the executive committee immediately in writing of changes of address. If the changes are not communicated, no disadvantages can develop for the association from it, developing costs go debited to the member.
8. Apportionments and / or benefits in kind can be raised by the members in the context of association meetings (e.g. in the context of the health island days / the Biike days / the Medicinale in Berlin etc.). The levying of levies and / or benefits in kind must first be decided by the Presidium and submitted for confirmation to the next General Assembly.
9. These contribution regulations can be changed by the presidency by resolution if necessary. The executive committee has to submit resolutions on changes to this fee schedule to the next general meeting.
10. All contributions of the association are to be paid to the association's contribution account. The bank details are:

11. The annual contributions must be paid by 31 March of each current financial year.
12. Reminder fees shall be charged if the payment deadline is exceeded. For reminders of premium payment, 1st, 2nd and last reminder each €25.00 and for court reminder notices all additional costs.
